


Of the 43 million

**Employment** opportunities for people with disabilities can be limited when they can't access basic workplace tools to perform their job duties.







#### YEARLY TREND OF ADA RELATED DIGITAL LAWSUITS

23% increase in 2020. Almost 10 lawsuits every business day.



ADA related cases in 2020 increased 23% over 2019. This includes cases filed in federal court and those filed in California state court under the Unruh Act with a direct reference to violation of the ADA.

#### What is Universal Design?


"Universal design is the design and composition of an environment so that it can be accessed, understood and used to the greatest extent possible by all people regardless of their age, size, ability or disability ...

### Basics of accessible websites and apps

- Compatibility with screen reader, voice command and magnification software
- Images labeled with alt text
- Form input fields labeled in right location
- Videos have closed captioning, transcript or both
- Headers labeled and used correctly
- High color contrast for low-vision users
- Buttons and links are labeled
